## 2026 Certification Fee Schedule

### OPEN TESTS

- FF-I, FF-II and HMO: \$230 per application (Association Companies)
- FF-I, FF-II and HMO: \$240 per application (Non-Association Companies)
- Haz-Mat Awareness: \$25 per application (All Companies)

Note: All written tests will be issued at the Cambria County Fire School Site Classroom. A \$10.00 National Pro-Board Fee has been included in the application fee.

### CLOSED TESTS

#### FF-I (12 Skill Stations)

- 1 to 24 Candidates: \$4,700 flat Fee (Association Companies)
- 1 to 24 Candidates: \$4,800 flat fee (Non-Association Companies)
- Over 24 Candidates: An additional \$230 per application (Association Companies)
- Over 24 Candidates: Additional \$240 per application (Non-Association Companies)

#### FF-II and HMO (5-6 Skill Stations)

- 2 to 24 Candidates: \$4,700 flat Fee (Association Companies)
- 2 to 24 Candidates: \$4,800 flat fee (Non-Association Companies)
- Over 24 Candidates: An additional \$230 per application (Association Companies)
- Over 24 Candidates: Additional \$240 per application (Non-Association Companies)

#### Haz-Mat Awareness:

- 10 Candidates Minimum: \$25 per application (All Companies)  
\$300 flat fee to issue written CLOSED exam at location different than noted above.

### RE-TESTS (Written and/or Skills)

- Any Re-Tests: \$20 if you originally tested at Cambria County
- Written Re-Tests: \$25 if originally tested at another site.
- Skills Re-Tests: \$25 per still station if originally tested at another site.  
(No charge for follow-up retests if the individual paid a \$25 fee for first re-test)

Deadline for applications is 3 weeks (21 days) prior to the written exam – NO EXCEPTIONS, this will allow ample time to have incomplete applications returned and corrected or accommodations needed prior to testing. No new applications will be accepted after the deadline.

### CANCELLATIONS/REFUNDS/NO SHOW POLICY:

Refunds will be determined by the date sent in the notice. Refunds for cancelling at any time will be subject to a \$15 processing fee. Refunds for cancellation sent to us between 7 and 14 days before the test you are registered for will be subject to a \$25 processing fee. Those who cancel within seven (7) days of the written exam you are registered for, or do not attend, forfeit the full application fee, which, if unpaid, will be invoiced.
